




# Certified EnMS Advisor

#### What is EEC Professional Certifications?

EEC Professional Certifications is an umbrella certification framework, under which multiple certifications sit, including:

- Certified Emissions Reduction Leader for Commercial Buildings
- Certified EnMS Advisor
- Certified Insulation Installer

It demonstrates the EEC's ongoing commitment to developing the future energy and related services workforce for Australia.



#### About this certification

Certified EnMS Advisors advise large energy using businesses on establishing systematic approaches for energy management to enable continuous improvement.

Implementing, and advising on the implementation of, an energy management system (EnMS) requires technical and soft skills from various fields. The Certified EnMS Advisor certification supports energy and related services professionals to understand how EnMS support businesses by reducing energy costs and emissions. The certification also supports these professionals to engage and influence business decision makers to invest in smart energy management in an ongoing way.





In 2020, the EEC worked with the NSW Government to develop the EnMS Advisor training program. The training program is a professional development course for energy and related services professionals to provide them the systems knowledge and engagement expertise to support implementation of an EnMS for large energy using businesses.

It equips professionals with skills to engage and influence senior executives to realise continuous improvement in energy performance.

The Certified EnMS Advisor certification is underpinned by the EnMS Advisor training program.

### Why get EEC Certified?

Certification gives individuals independent recognition of their training and experience.

Certified individuals join a community of trusted experts working to improve standards and practices in the energy and related services sector. Certified individuals stand out among those offering EnMS advisory services, as their skills have been assessed and verified.

#### What levels of certification are there?

EnMS Advisor certification offers two levels to recognise different experience in advising on the establishment and maintenance of an EnMS:



#### Certified EnMS Advisor

Certification as an EnMS Advisor is available if you are an energy and related services professional with at least two years of experience in energy management.

Certification demonstrates you have the knowledge and skills to effectively engage, advise and support a business to establish and sustain an effective EnMS.



## Certified EnMS Advisor at the Advanced level

Certification as an EnMS Advisor at the Advanced level is available if you are an energy and related services professional with additional experience supporting businesses to develop and deliver key elements of an EnMS.

Certification demonstrates you have the knowledge and skills to effectively engage, advise and support a business to establish and sustain an effective EnMS.

#### How to apply

You can apply for certification as a Certified EnMS Advisor at **eeccertified.org.au**.



You must meet pre-requisites for certification before an application is considered. Meeting the pre-requisites does not guarantee you will be certified, it means your application will be assessed in detail. As a candidate for certification as an EnMS Advisor you must:

complete the EnMS Advisor training provided by the EEC; and

meet the minimum experience requirements for the level of certification you are applying for as a pre-requisite for application.
