What is EEC Professional Certifications?

EEC Professional Certifications is an umbrella certification framework, under which multiple certifications sit, including:

0	eec CERTIFIED emissions reduction leader	Certified Emissions Reduction Leader for Commercial Buildings to project manage integrated building energy retrofits that slash energy bills and emissions
0	eec CERTIFIED EnMS advisor	Certified EnMS Advisor to effectively engage and influence large energy using businesses to set up energy management systems (EnMS) that enable them to realise continuous improvement in energy performance and emissions reductions
0	eec CERTIFIED insulation installer	Certified Insulation Installer to support households with lowering heating and cooling bills whilst ensuring improved health and comfort outcomes are realised by safely and effectively installing insulation

EEC Professional Certifications is supervised by an expert Steering Committee and administered by the EEC, Australia's peak body for energy management, energy efficiency and demand flexibility. It demonstrates the EEC's ongoing commitment to developing the future energy workforce for Australia.



Why get EEC Certified?

Certification gives individuals independent recognition of their knowledge and skills.

Certified individuals join a community of trusted experts working to improve standards and practices in the energy and related services sector.

Certification shows you have the skills and expertise to implement the energy and related services or upgrades for which you're certified.

When businesses and households look for someone to deliver their energy and emissions reduction, building retrofit or insulation project, they need look no further than individuals certified under EEC Professional Certifications.

Who can become certified?

Anyone who meets the knowledge, capability and other requirements set out in the Framework Rules and relevant sub-rules.

How can individuals develop the skills to become certified?

EEC Professional Certifications sets clear benchmarks necessary for certification. For Certified Emissions Reduction Leader applicants their experience enables them to develop the necessary knowledge and skills. For Certified EnMS Advisor applicants they complete EnMS Advisor training program, which directly addresses areas of competency. When applying for certification at the advanced level, their experience enables them to develop the necessary knowledge and skills. For Certified Insulation Installer applicants, they complete required training that directly addresses areas of competency.

How much does it cost to become certified?

Fees vary for each certification. All fees are available on **eeccertified.org.au**.

How are fees set?

Fees are set by the EEC Board. Fees for certification and re-certification reflect the costs of engaging senior industry professionals to assess applications, and conduct assessment interviews for some certifications. Fees contribute to the cost of running EEC Professional Certifications.

Do I need to be a member of the EEC to be certified?

No, but discounts apply for EEC members.

How do you ensure application assessments are independent?

Certification applications are assessed by an independent Assessment Panel. The Assessment Panel is made up of senior industry professionals from across the industry relevant to the certification. Assessors declare any potential conflicts of interest and assessment decisions. See the Guides for Candidates for more information.

How do you ensure application assessments are confidential?

Assessors sign a confidentiality deed, ensuring that they do not disclose confidential information disclosed as part of the assessment process.

How do you ensure application assessments are consistent?

Confidential Evidence Guides have been developed by the Secretariat, with support from the Assessment Panels. These guides define the appropriate knowledge and skills required for each certification and certification level.

What are the certification sub-rules?
